SECTION 4: FIRST AID MEASURES

Inhalation: Remove to fresh air, seek medical advice if symptoms persist.

SECTION 6: ACCIDENTAL RELEASE MEASURES

Handling: Avoid breathing vapors. Avoid contact with skin and eyes. Keep away from heat/sparks/open flames. Use in well-ventilated areas. Do not eat, drink or smoke when using this product.

Storage: Store in sealed bottle, tightly closed container in a cool, dry, well-ventilated place. Recommended storage temperature 15–25°C. Indoor storage should meet OSHA standards and appropriate fire codes.
